RULES

1. Acro Clube da Maia, an acrobatics sport, launches the contest “**MIAC 2009 Online Mascot**” beginning in 1st October 2008 and ending in 31st October 2008 for proposals reception, finishing by the 20th November 2008 the online voting.
2. The official contest results will be displayed in the following websites, including the winning proposal details and the winner description before the 30th November 2008.
3. This contest only accepts proposals sent by the Internet. Anybody can submit mascot proposals (one or more), as long as they fulfill the contest requirements.
4. The proposals may be individual or collective.
5. The contest will be hosted on the websites of Acro Clube da Maia (www.acroteam.org) and MIAC 2009 (www.acroteam.org/miac09/), which will be kept updated in terms of deadlines, received proposals and voting.
6. A jury of Acro Clube da Maia will pre-select the mascot proposals. Only the selected proposals will enter the contest. The other proposals will also be displayed on the websites, but in a special “non-accepted” area with a short explanation. If desired, the rejected proposals may be edited and then resubmitted to the contest.
7. The Board members of Acro Clube da Maia will be the contest jury. This jury will only analyze the admissibility of each proposal and will not participate or influence the voting process and decision.
8. The selected contest proposals will be ranked by an online voting process, whose results will be continuously updated on the websites and made publicly available.
9. Acro Clube da Maia will be the owner of all submitted proposals and will have all rights for future uses. The contestants will be not allowed to use the submitted proposals, unless previously authorized by the organizing entity.

10. Every proposal must be accompanied by the following items:
 - a. Detailed description of the mascot content;
 - b. Drawing, as explicit as possible;
 - c. All necessary information for the mascot production;
 - d. Bright colors should be preferably used, mainly:
 1. Red;
 2. Yellow;
 3. Green;
 4. Blue.
11. The contest participants will be identified by Name, Address, Phone Number, Email Address, Passport Number, Country of Origin and Sport Affiliation (the last two items are not mandatory).
12. The winner participant will have to send by email to Acro Clube da Maia a Proof of Identity and a Bank Account Number for electronic prize payment.
13. To ensure privacy, only Name, Country of Origin and Sport Affiliation (if any) of the contest winner will be posted on the contest websites.
14. After the winner being chosen and announced, a mandatory proof of identity and authenticity will also be posted online.
15. All future uses of the winning mascot by Acro Clube da Maia are automatically acknowledged by each contestant during proposal submission. Every contestant also acknowledges that any results deriving from any kind of mascot use will only belong to Acro Clube da Maia.
16. The prize money for the winning mascot is:

100 USD
17. O aforementioned prize money will be payed by means of bank transfer no more than 90 days from the closing day of the online voting.
18. Acro Clube da Maia will inform the winner contestant, by email or other suitable means, as well as all other contestants, of the winning mascot. It will also keep the contest results online for at least 90 days.
